### Candice Pinares Baez Session Title: "Adult-Student Interaction, Watch the Boundaries"

**Program Description:** The world is different today when it comes to student interactions. Well-meaning conversations, promised confidentiality, looking the other way, pool parties, enthusiastic hugs, and the friendly squeeze are all ingredients that would not have caused a second look ten years ago.

Today, those same actions can lead to student claims that may result in a range of actions: from the loss of career, to the defense of a lawsuit, or even facing criminal charges. When you add social networking, texting, smart phones, and pop culture's sexualization of adolescents the situation can quickly evolve into something truly tragic for all involved.

Participants will work through several boundaries scenarios and learn the potential liability that could arise from even well-intended behavior. They will also gain an understanding of why perceptions have changed and will receive concrete guidelines on how to change behavior to avoid liability and prevent risky situations that invite poor judgment.

**Speaker Bio:** Candice C. Pinares-Baez is an associate in the Fort Lauderdale office of Fisher & Phillips, LLP. Her practice is focused on defending employment-related matters, including claims for age, race, sex, disability, religious, and national origin discrimination arising under the various civil rights laws, as well as claims involving family leave issues, wage hour matters, and breach of contract.

Bena Kallik, Ph.D. Session Title: "Habits of Mind"

**Program Description:** With all of the focus on "the common core" and getting students "college and career ready," it is easy to lose sight of the fact that we are educating students and helping minds and people grow and mature, not creating workers to fit into some international testing system. We recognize that difference when we talk about the gap between what we value as educational essentials and how we evaluate results. One key question is how we can be true to our values while still addressing issues of accountability.

"Minding this gap" has been the focus of the most recent work of Bena Kallick and Art Costa. In *Learning and Leading with Habits of Mind,* they discuss 16 Habits of Mind that are essential to knowing how to behave intelligently under challenging situations; habits of mind that create a foundation for what we want for students.

In their most recent book, *Dispositions: Reframing Teaching and Learning* they build on the Habits to focus on how to structure learning environments to build on student strengths and get the results we want.

In this general session, Bena will describe the Habits of Mind and provide rich examples of practice in which the Habits are taught and assessed.

**Speaker Bio:** Bena is the Co-Director of Institute for Habits of Mind and Program Director for Eduplanet21. She is a well known consultant providing services to school districts, state departments of education, professional organizations, and public agencies throughout the United States and abroad.

Some of her written work includes: Assessment in the Learning Organization (ASCD, 1998), the Habits of Mind series (ASCD, 2000), Strategies for Self-Directed Learning (Corwin Press, 2004), Learning and Leading with Habits of Mind (ASCD, 2008), Habits of Mind Across the Curriculum (ASCD, 2009), Dispositions: Reframing Teaching and Learning (Corwin, 2014) (all co-authored with Arthur Costa), and Using Curriculum Mapping and Assessment to Improve Student Learning (Corwin Press, 2009, (co-authored with Jeff Colosimo). Her works have been translated into Dutch, Chinese, Spanish, Italian, Hebrew, and Arabic.

Her work with Dr. Art Costa led to the development of the Institute for Habits of Mind (<u>www.instituteforhabitsofmind.com</u>), an international institute dedicated to transforming schools into places where thinking and Habits of Mind are taught, practiced, valued and have become infused into the culture of the school and community.

She and Art Costa have an online course using the EduPlanet21 platform. Eduplanet is a company dedicated to Professional Development for Educators using the most contemporary tools and thinking to be successful engaging students and teachers as 21<sup>st</sup> century learners.

Kallick's teaching appointments have included Yale University School of Organization and Management, University of Massachusetts Center for Creative and Critical Thinking, and Union Graduate School. She was formerly on the Boards of the Apple Foundation, Jobs for the Future, Weston Woods Institute, and Communities for Learning.
